Highlights

What do I need to know now?

- CCBH will be replaced by Cerner Millennium (Cerner) as the Mental Health System of Care (SOC) electronic health record (EHR) in April 2024
- Cerner is a completely new EHR, not an update to CCBH
- The project is currently in the design and build phase, where Cerner customizes the EHR according to SOC specifications
- The goal is to optimize the EHR to best support client needs, SOC workflows, and regulatory requirements.

SOC Impacts: Functionality

How will the new EHR impact me?

- Increased ease of use for clinicians
- Reduced need for hybrid charting through new scanning functionality
- Fewer clicks while working in assessments and treatment plans
- Greater team collaboration on client plans
- Customizable homepages tailored to individual workflows
- Availability of e-signatures on clinical documents

SOC Impacts: Training

Early Information

- All CCBH users will require training in January - March 2024.
- Training plans are actively being developed.
- The SOC has shared training-related input via the demo sessions
- **All sites will be responsible to ensure all Cerner users complete training prior to go-live.**

SOC Impacts: Go-Live Preparation

Early Information

- All sites will need to prepare for the go-live
- Downtime procedures will be required
- The BHS Management Information Systems (MIS) team will provide recommendations for go-live preparedness

SOC Impacts: Information Gathering

Early Information

- BHS may require information from the SOC prior to go-live to support system readiness.
- This may be in the form of system-wide surveys or reporting to your CORs.
- For example, on-site contacts for issue reporting during go-live.

SOC Actions: Raise Awareness

What should the SOC do now to prepare?

- **Communicate early and often with your staff to raise awareness about the magnitude of change they can expect.**
 - Share information at staff meetings as a standing agenda item
 - Post flyers at workstations and in break rooms
 - Make a game of learning new terms
 - Encourage staff to participate in BHS review meetings, town halls, and to ask questions

SOC Action: Identify Champions

What is a champion?

- During go-live, the role of a site champion is to:
 - Act as the “go-to” person for their site
 - Generate excitement & alleviate fears
 - Answer questions and support staff as the on-site Cerner “expert”
 - Facilitate communication between the site and the County
 - Assist in reporting issues to the help desk
 - Participate in briefings prior to and during go-live

SOC Actions: Identify Champions

What should the SOC do now to prepare?

- **Identify champions at each facility**
 - The number of champions needed will depend on size and type of facility - SOC leaders will need to assess facility needs
 - What makes a good champion?
 - Experienced front-line Cerner users, respected by their colleagues
 - Strong communicators who are detail oriented
 - Troubleshooters who enjoy resolving issues
 - Future preparation:
 - Champion names and contact information will be requested
 - Ensure champions participate in early training & briefings



SOC Actions: Stay Informed

What should the SOC do now to prepare?

- **Maintain awareness about project status in order to prepare in advance for the Cerner go-live.**
 - Participate in [town halls](#), review resources and status updates on the [website](#), and talk to your supervisor or COR.

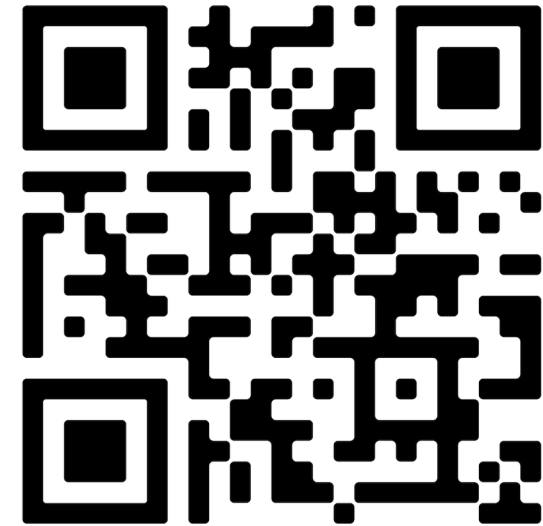

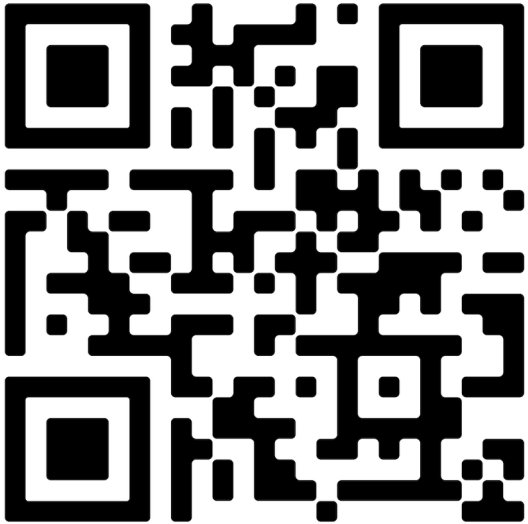

Question	BHS Response
Engagement and Participation	<i>Will there be an opportunity for prescribers to serve as a SME?</i> Yes, as workshops are presented that include relevant topics, we will reach out for requests for participation. If you currently have any prescribers who have offered to participate, please send the information to heather.rey@sdcounty.ca.gov .
Functionality	<i>Does larger font also mean that writing boxes can be larger, so we can see the entire paragraph we are writing?</i> Unfortunately, the writing boxes cannot be made larger, only the font.
	<i>Will there be a simple way to scan/upload and access wet signature documents such as ROIs?</i> Scanning functionality is possible in this application.
	<i>Will it be easier to correct errors to billing?</i> We have not yet seen full product, so we are unable to provide a complete response at this time. We will address in future updates.
	<i>Will there be any functionality added that may eliminate the need for other systems such as DCR (Data Collection Reporting)? This is a state database/system through UCSD, also mHOMS.</i> This request is being reviewed and more information will come as the product is developed.

Cerner Millennium Implementation Leadership Talking Points



The following information will be shared by BHS leadership at all standing meetings with Mental Health System of Care (SOC) leadership whose organizations are Cerner users.

Project Highlights

- **CCBH will be replaced by Cerner Millennium** (Cerner) as the Mental Health System of Care (SOC) electronic health record (EHR) in April 2024; Cerner is a **completely new EHR**, not an update to CCBH.
- The project is **currently in the design and build phase**, where Cerner customizes the EHR according to SOC specifications; the **goal is to optimize the EHR** to best support client needs, SOC workflows, and regulatory requirements.
- **End-user participation is critical** during this phase. Any end user with expertise and interest in participating to support design decisions is encouraged to contact BHS as soon as possible.

SOC Impacts

- Early reports from the design and build process indicate **Cerner will be a more efficient and effective EHR for Cerner users**, including increased ease of use, reduced hybrid charting, fewer clicks, greater collaboration, customizable home pages, and availability of e-signatures.
- All **CCBH users will require training** in January - March 2024. Training plans are in development and will be shared when they are available.
- All **sites will need to prepare for the transition**. BHS will communicate recommended preparations including any downtime procedures prior to go-live.
- **BHS may require information gathering from the SOC** prior to go-live to **support system readiness**. For example, device lists to ensure compatibility, or on-site contacts for issue reporting.

Actions the SOC Should Take Now to Prepare

- **Communicate with your staff.** Share information about the new EHR and what to expect at team meetings. Post [flyers](#) at work stations and break rooms. Share [new terms](#) with staff.
- **Identify EHR Champions at each site.** During go-live, a champion will act as the "go-to" person for the site to answer questions, facilitate communication, and report issues. Champions will have access to early training and additional support from BHS. BHS recommends at least two champions per discipline.
- **Stay informed.** As SOC leadership, maintain awareness about project status in order to prepare in advance for the Cerner go-live. Participate in [town halls](#), review resources and status updates on the [website](#), and talk to your COR.
