

Running Reports in CCBH


A general guide for running a report is outlined below. The steps to run all reports are very similar. This example shows how to run the Client Roster report.

From the Clinician's Home Page Systems button, follow the path to Client Roster Report:




The report View displays (see pic below). This View consist of multiple tab pages on the top referred to as Selections1, Selections2 and so on.


Select the **Load** button to open the templates view:



The template menu displays with multiple types of reports. When a template is selected, click the Load button again:



Always change the Units and select your Unit. Otherwise you will run a report for the entire system of care:



Selections tabs may be used to gather the criteria required for the report. In the Reports Training you will receive specific instructions.

You can print the report to your screen, or you can export to a csv file. Reports can also be Batched for long reports running at specified times.
